If my nomination is approved by the Membership Committee and the Board of Directors, I agree to comply with, be bound by, and observe the Bylaws and Rules and Regulations of RVCC as currently stated and I further agree to abide by any future revisions of said Bylaws and Rules and Regulations of RVCC. I grant permission to have a credit check done by RVCC. I acknowledge that this nomination is not binding on RVCC unless and until accepted by the RVCC Board of Directors. All disputes between Rogue Valley Country Club and nominee shall be submitted to binding arbitration in accordance with the provisions of Oregon Revised Statutes 36.300 et seq. However, RVCC is not obligated to submit to binding arbitration monetary disputes that may arise due to a member's failure to pay any past due monetary obligations to the club. The member shall be responsible for all costs including collection fees, attorney fees and any filing fees incurred by RVCC in its efforts to collect any and all past due amounts. The non-prevailing party shall bear the expenses of an arbitration proceeding unless the arbitrator determines otherwise. Judgment upon the award rendered may be entered in any court of competent jurisdiction.

I may withdraw my nomination at any time prior to approval. In such event, the deposit accompanying my nomination will be fully refunded but will not accrue interest during the holding period. I understand the Initiation Fee may be subject to change.

Pursuant to the Bylaws Article II: Membership Section 4 – Families of Members...“The member’s family also includes the children of the member, and the member’s domestic partner or significant other, provided the child has not reached the age of twenty-one (21). With the favorable endorsement of the Membership Committee, the Board will have the discretion of continuing the privileges to a Member’s unmarried children, who are full-time college or university students, and are not over the age or twenty-three (23).” This privilege is not afforded to Member’s Individual Membership category.

JUNIOR EXECUTIVE OR YOUNG EXECUTIVE MEMBERS RESIGNING FROM THE CLUB ARE ONLY RESPONSIBLE FOR THE INITIATION FEE IN THE MEMBER CATEGORY THAT MATCHES THEIR AGE AT THE TIME OF THE EFFECTIVE TERMINATION DATE.**
